Please note the transfer of Sagiper warranty is subject to the following procedures and conditions:

- New property owner to send **Warranty Transfer Form** to Sagiper North America Inc. Transfer requests sent by email are preferred, and are typically processed faster.
- Sagiper will review the request for warranty transfer and will contact the new owner to advise if the warranty transfer has been accepted.
- If Sagiper doesn't receive complete information, the request for warranty will be void.
- If Sagiper doesn't receive completed **Warranty Transfer Form** within 30 calendar days of change of property ownership, the warranty will be void.
- If the **Warranty Transfer Form** information is unclear, Sagiper may request additional information.
- Any courier or other related costs associated with the warranty transfer are not the responsibility of Sagiper. Typically, there aren't any associated costs with a Sagiper warranty transfer.
